TREASURES REPORT

• Heather reported the current balance is \$4867.87 with the poker ride bringing in \$2058.00 (\$1764 after expenses).

BUSINESS ARISING FROM PREVIOUS MINUTES

Fence Posts/Paint/Work Update

• David would like to contract Jason Teale to keep the fence posts in good order on an ongoing basis and to give us a quote on lifting the shelter up when money permits.

Tractor Storage

- Discussion held about possible purchase of storage container for the tractor. An 8' x 20' x 8'6" Dry Freight ISO container from Delta, BC would cost us \$1825 plus delivery. Alternatively the tractor stays in the concession building year round. Kristin mentioned that Stacy Carlos of the Appy Club may be keen to learn how to use the tractor, harrow the rings and put the tractor away afterward their shows so that they can access their jumps without maneuvering around the tractor.
- Decision was reached to leave the tractor where it is so there will be no need to purchase a storage container.

POKER RIDE DEBRIEF

- Kristin set the flags out for the route and Lara and Heather rode the route first on the morning of the poker ride and reported some of the flags were already down. Next year whoever goes out first will bring some more flags along to replace any missing ones.
- Next year, NO EXCEPTIONS, if people do not show proof of their horse council number, they will not be allowed to ride.
- No riders will be allowed out on the poker ride route past a certain specified time to avoid delays.
- Overall the poker ride went very well. The 2015 ride made \$2030 and the 2016 ride made \$2058. After all expenses for 2016 we made \$1764.
