APPROVAL OF PREVIOUS MEETING MINUTES: an error in reporting from the October 10th meeting was noted as follows:

TREASURER'S REPORT:

Revenues and expenses since October 10th as follows;

-There is a shortfall of funds in the bank compared to totals documented. Some of the funds have not been deposited yet

FACILITIES:

- Water in concession area of building: Proline Roofing came out and could not see any wetness on ceiling during heavy rain. The roof is not leaking. The water must be blowing in from the front or the side over the pony wall. Most likely through the front because the concrete pad extends to the edge of the roof line. The water is pooling due to sloped floor.
- Work party proposed for December 1st from 9am-12pm. Branches on the roof need to be cleared, leaves on arena need to be delt with, damaged fence requires repair. We need to check that there are enough screws for the fence repair. EBLES will provide hot chocolate /coffee and snacks for volunteers.
- Invasive snake species in park (common water snake) There have been 4 sightings, one caught. Not poisonous, but need to use caution when catching as they will bite. They are looking for places to overwinter. One found in the announcer's booth. Asking to report sightings to the response team.
- An email was received from Emily Lomas that we will forward to the membership on what to do if they see a snake.
